	_ I will not sell or share my medication with others. I understand if I do, my treatment will be stopped.
	_ I will sign a release form to let the provider speak to all other providers that I see.
	_ I will tell the doctor all other medications or supplements that I take and call the office right away if I have
a pre	escription for a new medication to avoid any drug interactions.

We will work with any other providers you are seeing to assure you are being treated safely and effectively. If you become addicted to these medications and exhibit signs and symptoms of substance abuse, we will help you get treatment and off the medications safely.
